

City Tax – General Information

What is the City Tax? Who has to pay it and why?

In accordance with the legislative decree No. 4/2011, the **Unione Pedemontana Parmense** has established the **City Tax** (Council resolution No. 5/2018) in the areas of **Collecchio, Felino, Sala Baganza** and **Traversetolo**. With the same resolution it has also been approved the application rules (Click **HERE** to download it).

The City Tax has to be paid, directly to the facilities, by people who stay in the same tourist accommodation (For example hotel, apartments, B&B and campings) for a maximum of 7 consecutive nights. It ranges from 30 eurocents to 2 euros per person for every single night, depending on the accommodation rating.

Finally, it's important to know that the whole revenue will be used only to fund tourism activities, including those supporting accommodation facilities.

Exemptions

Exemptions from the payment of the City tax are provided for:

- Youth under 14 years of age;
- People recovered in out-patient facilities (Day Hospital);
- Family members and/or relatives or carers, limited to the period of hospitalization, of patients whose hospitalization takes place in sanitary facilities in the province of Parma. They will be exempted upon release of an attesting document according to articles 46 and 47 of D.P.R (Presidential Decree) n. 445 of 2000 and subsequent modifications, declaring that the stay at the accommodation is aimed at providing health care for the family member;
- People and rescue volunteers (coordinated by public authorities) staying in accommodation facilities due to natural disasters, or extraordinary social emergencies;
- All levels students under 32 years of age, enrolled in State-recognized schools and universities in the province of Parma;
- One coach driver and one tour leader/tourist guide, assisting organized groups by travel and tourist agencies, for every 25 group members;
- Employees working in the same accommodation facilities;

- People who stay in the accommodation facilities for promotional purposes, after having communicated it to the Touristic service of the Unione Pedemontana Parmense;
- State and local policemen, firemen and other personnel belonging to armed forces who for reasons of service stay overnight in the area of Unione Pedemontana Parmense, limited to the period of service itself;
- People residing in the municipalities of the Unione Pedemontana Parmense;

The accommodation facilities are provided with exemption forms to be filled in
